I understand that Suspend This is not a government organization or affiliate and acts independently of the Parole Board of Canada.

I authorize Suspend This to obtain on my behalf all relevant information and documentation from the police, courts, RCMP, military, and Parole Board of Canada, and correspond with them accordingly. I extend this authorization to include youth and pardoned criminal record information.

I understand that should I come into contact with the police (regardless of the outcome of said interaction) while my application is in process, that additional fees will apply to be paid by me.

I also understand that any delays on the file caused by my own actions, including late payments, outstanding fines, or further criminal activity, will result in additional fees to be paid by me and could postpone my application.

I acknowledge that Suspend This is not responsible for government processing, and that as a result any estimated timeframes provided by them or their agents are not guaranteed.

I further acknowledge that pardon legislation and government fees can change without notice impacting my application, and the outcome of said changes are not the responsibility of Suspend This.

I understand that the fees paid to Suspend This are for the preparation of the file only, and do not include any associated government fees.

I understand that the outcome of my request for a pardon lies solely with the Parole Board of Canada, and that Suspend This does not guarantee the result of my application.
